- The total income for January was \$100,577 which included annual assessments of \$100,203, advertisement revenue of \$180, garage sale income of \$84, fines of \$100 and interest of \$10. Total expenditures were \$6,099 which covered common grounds maintenance of \$2,141, electricity of \$748, annual meeting costs \$100, clubhouse rent and our share of utilities of \$460, legal of \$72, Florida corporate reporting fees of \$61, directory printing costs of \$2,118, website maintenance costs of \$275 and administrative costs of \$124. It should be noted that our directory ads revenue reduced the net directory cost to roughly \$400 or about 57 cents per copy. The total cash (including savings) at the beginning of January was \$135,699 and increased to \$230,177 at the end of January since income exceeded expenses by \$94,478.
- We sent out 772 annual assessment notices and have thus far received 680 back. We want to thank all of you who paid your assessments promptly in January. Our efforts now go to the collection of the remaining outstanding assessments which in the past has proven to be a very time consuming task. We will keep you posted.
