President's Letter

Can you believe that we have a free service called "Shout Out" for our website, ghoaonline.com? Our webmaster, Ruthie O'Neill, alerted us to this service available for communities of our size (700 plus residents). Particularly useful for our community would be emergency alerts or other notifications pertinent to our community. Safety is the number 1 concern for our community and this service will certainly assist in this manner. What do you need to do? Sign your name and give us your e-mail address. The signature slips will be in your assessment mailing coming after Christmas. Just mail the signed slip back with your assessment payment and card in the envelope provided.

GHOA has been very fortunate from its inception to have knowledgeable and willing volunteers to serve on the Board, particularly in the treasurer's capacity. The time has come to outsource a major portion of the treasurer's responsibilities to a CPA company. It is timely to make the transition since our assessments are due January 31, 2015. This "yet to be named" accounting firm would start by receiving the individual assessment cards and money. They would then maintain the appropriate sections of Quick Books. After a few weeks, the second letter will be sent by the accounting firm to those who haven't paid. After failure to pay at this point, Mark Breed's Office will be notified to start the lien process. In the meantime, the CPA company will be responsible for bill paying and receiving/depositing checks. Monthly statements will be developed and monitored by the Board's treasurer for our monthly Board meetings. The treasurer will work with the accounting firm regarding estoppels. The current Excel spread sheet will be maintained for actual and remaining budget accounts. All of the appropriate federal and state reports will be prepared. With this outsourcing of the treasurer's responsibilities, the Board determined an increase in the yearly assessment from \$150 to \$165 was warranted. The accounting firm will add an additional line item to the budget.

With the holiday season rapidly approaching, the Board wishes you all a joyful and peaceful season. Working for you, Sandy Todd

"Recipe of the Month"

Tex-Mex Skillet

Ingredients

1 envelope all-purpose meat marinade 16 oz. can tomatoes, cut up

1 ½ lbs. beef round steak, cut into thin strips

14 oz. can green chilies, drained, seeded, and chopped

1 t ground cumin

1 clove garlic, minced

1 t sugar

1 15 oz. can refried beans

2 c cooked rice

½ c shredded cheese

½ c sour cream



Directions

In 12 inch skillet, combine dry meat marinade and undrained tomatoes. Stir in steak strips; let stand 20 minutes. Add chilies, cumin, and garlic. Bring to a boil. Reduce heat and simmer uncovered 15 min, stirring often. Add beans and rice, mixing well. Heat through. Top with sour cream in center, and ring with shredded cheddar. Cover and heat 2-3 minutes. Remove from heat, service at once.

RULES TO REMEMBER

- Residents are reminded that NO ONE UNDER THE AGE OF 14 IS ALLOWED TO DRIVE A GOLF CART DURING THE DAY/NIGHT. AFTER DARK ONLY THOSE 18 OR OLDER ARE ALLOWED TO DRIVE A GOLF CART. THIS IS STATE LAW. (GOLF CART MUST HAVE LIGHTS FRONT AND BACK.)
- Only 2 dogs are allowed per household. Dogs are to be confined to their own yard or on a leash when being walked. OWNERS ARE EXPECTED TO CLEAN UP AFTER THEIR PETS.
- Fences cannot be higher than 6 feet tall.
- If a lot owner is contemplating doing changes to his property, (fences, garages, new rooms, patios, new garage, pool, etc.) the change must be Okayed by the architectural committee. Please call Shirley Kuznarik 382-3656 or kuzfla@yahoo.com

- Contractors (including yard workers) are not allowed to work on Sunday in GH. Residents and contractors should not start yard work until AFTER 8:00 A.M.
- Residents are asked to keep outside lights on at night in order to provide security for the development.
- Residents are reminded that lawns are to be sodded front to back and mowed once a week during growing season.
- Please do not put cut branches and bushes on undeveloped lots .
- Please make sure that lawn clippings are removed from paved and street areas when lawn mowing.
- Garage sales and estate sales are NOT permitted in GH.
- No signs, other than "For Sale" signs can be placed on any lot.

*Treasurers Report, Tom Senior, 314-0644, tomseniorjr@aol.com*The total income for October was \$907 which included \$900 for advertising and interest of \$7. Total expenditures were \$5,699 which covered common grounds maintenance of \$3,820, electricity of \$686, Newsletter costs of \$449, clubhouse rent and an estimated share of utilities of \$521 (\$31 for September and an estimate for October of \$490 which we now know is too high), website maintenance costs of \$200 and administrative costs of \$22.

The total cash (including savings) at the beginning of October was \$193,194 and decreased to \$188,402 at the end of October since expenses exceeded income by \$4,792.

Shirley Kuznarik spoke about Halloween in GH. She stated that she did everything she could possibly do to get police

officers to be in attendance. Unfortunately, none were available. She felt that even though the roads were clogged, things went smoothly and indeed there seemed to be less people than last year.

Judy Trier has set the date for the GH Garage Sale for Saturday, January 10th. She is going to have to raise the fee for vendors in order to hire a police officer to direct traffic. If there is not a good response, she will cancel the sale.

Tom Senior announced that the Annual Meeting will be on Saturday, January 17th, 2:00 P.M. at The Christian Church of Sebring (where it was held last year).

Tom also spoke about renewing the lease on the clubhouse. He tried to get it for longer than one year with the same terms as the last two years, but Jason wouldn't go along with that. The Board can have the clubhouse for one more year with the same terms as the previous two years. Judy Trier moved that the Board accept the renewal of the lease on the clubhouse for one more year. Tom seconded. Tom, Judy, Millie, Connie, Sandy, Hardric, and Shirley all voted for the motion. Tom Senior then spoke about the difficulty that the Board is having in getting people to run for four offices. Before the night's meeting there was no one who turned in a resume. If no one agrees to run there will only be five people on the Board. Since he is not running again, there will not be a treasurer. He suggested that the job of treasurer be outsourced. It is a time consuming job January, February, and March due to the influx of assessments. Therefore he has asked for bids from three different companies or people. He built into the budget, money to pay for services from a bookkeeper. He suggested that even though we have a turnover of about \$165,000, we get new revenue to pay for a bookkeeper. He felt an increase of ten percent or \$15 in the assessment would cover the cost. Judy Trier moved that there be an increase in the annual assessment of \$15, moving it to \$165. Connie seconded. Tom, Sandy, Connie, Shirley, Judy, Millie, and Hardric unanimously approved the motion.

Millie Grime discussed the Shout Out Program that the Board is considering to alert residents with e-mail addresses about announcements etc. The Shout Out Program is a free software program that works in conjunction with the GHOA website. The webmaster would use the e-mail addresses to alert residents about emergencies/safety concerns, up-coming events, and any other kind of report that the Board thinks would be important for GH neighbors. In order to be included in the program, residents would have to sign a release slip agreeing that their e-mail address can be included in the e-mail list. The release slip would be sent out with the assessment card so it would not cost more to get it to all 780 residents. Residents would return the permission slip with their assessment by mailing it or putting it in the box at the Clubhouse or the Pro Shop. The e-mails would be in the data base that would be given to the webmaster. Connie would alert Ruthie, the webmaster, when any new permission slips were presented to the welcome committee or street captains. Millie Grime made a motion that the Board send out release slips with the assessment card. Shirley Kuznarik seconded. Tom, Millie, Shirley, Sandy, Connie, Hardric, Judy voted unanimously to accept the motion.

Neighbor comments

A resident asked how much carry over there was for the year. Tom Senior reported a \$40,000 carry over for the year to make a grand total of \$165,000. Even though this is a large amount, Tom felt that we should reserve this money for emergencies and generate new income for new services. He also reiterated that it is hard to get paving companies to come in each year to bid on paving projects when we only have a small budget for that each year. By paving every two years we have more money for bigger paving projects and then can get more paving done. He researched into how much money has been spent over the years. Since Golf Hammock was founded, a quarter of a million dollars was spent on roads the first ten years and another quarter of a million dollars was spent on paving the second ten years.

Sandy Todd discussed the problem with getting people to run for the Board. Several people she has spoken to have said that having it on Wednesday night is a problem since choir practice in many churches is the same night. She felt that if the Board had the general meeting on Tuesday night, we might get more interest from residents. The Board will discuss this for the future.

Shirley Kuznarik remarked that having the workshop on a different day is a hardship for her. If the Board met right before the general meeting, perhaps that would make it easier on Board members.

Another resident discussed Halloween and the problems of traffic. She felt that with all the kids and parents walking in the road, there was a real safety risk especially if an ambulance or the police had to come into GH.

Others spoke about the length of time (6-9). One resident asked residents to go to the commissioner's meeting and ask that the time be reduced to 6:00 to 8:00.
